What is the purpose of this update?

What are the risks of investing?


The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?


Example of how this applies to an investor

Annie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Annie incurred a loss after fund charges were deducted of -\$257 (that is -2.57% of her initial \$10,000). Annie did not pay any other charges. This gives Annie a total loss after tax of -\$285 for the year.

What does the fund invest in?


This shows the types of assets that the fund invests in.

Currency hedging

The fund's exposure to assets denominated in foreign currencies was 16% of which 99% was hedged back to NZD.
