#### What is the purpose of this update?

This document tells you how the Mint Australasian Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mint Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Fund invests predominantly in Australasian equities and targets medium to long-term growth. The Fund is benchmarked against the S&P/NZX 50 Gross Index with an investment objective of outperforming the benchmark after fees and expenses over the medium to long term.

#### What are the risks of investing?

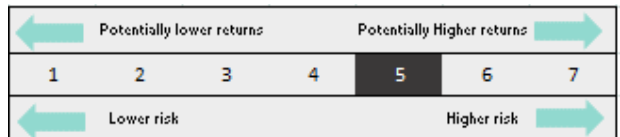

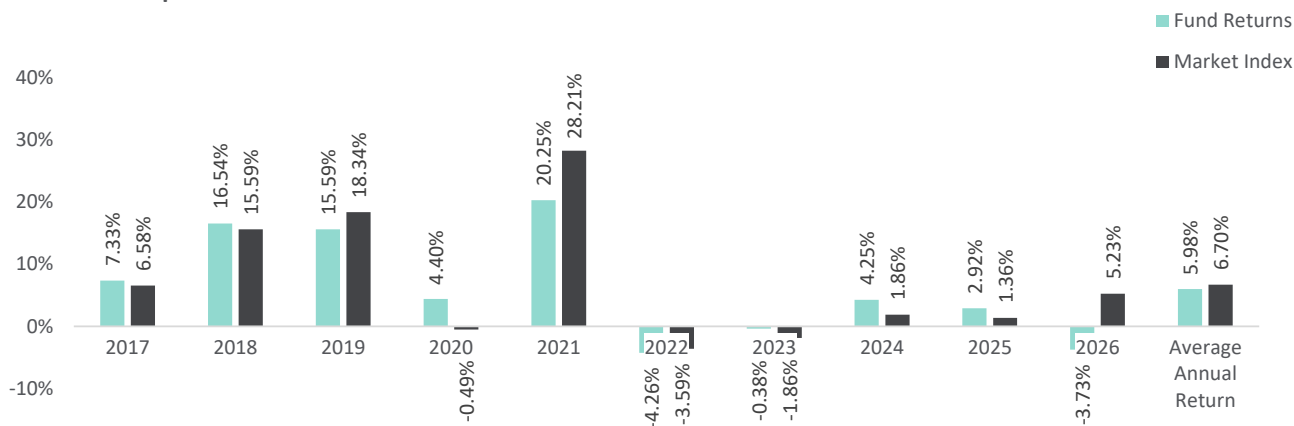
#### How has the fund performed?

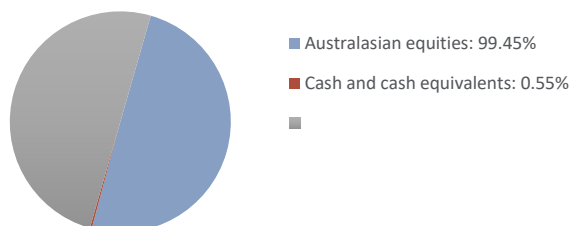
## Example of how this applies to an investor

Annie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Annie incurred a loss after fund charges were deducted of -\$367 (that is -3.67% of her initial \$10,000). Annie did not pay any other charges. This gives Annie a total loss after tax of -\$373 for the year.

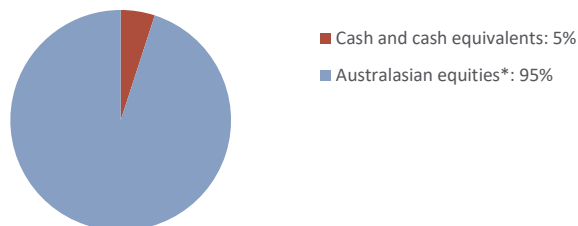
## What does the fund invest in?

## Currency hedging

The fund's exposure to assets denominated in foreign currencies was 17% of which 97% was hedged back to NZD.
