What is the purpose of this update?

This document tells you how the Mint Diversified Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mint Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund invests across a range of asset types which includes New Zealand and international equities (including listed property if held), but will also hold cash and fixed interest. The objective of the Fund is to deliver returns in excess of the Consumers Price Index (CPI) by 4.5% per annum, before fees, over the medium to long term. The relevant market index for the Fund is a composite index derived from the underlying asset classes of the Fund.

What are the risks of investing?

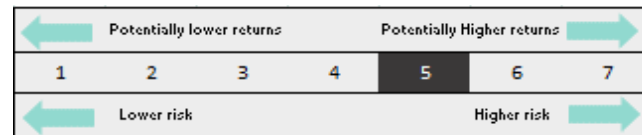
The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

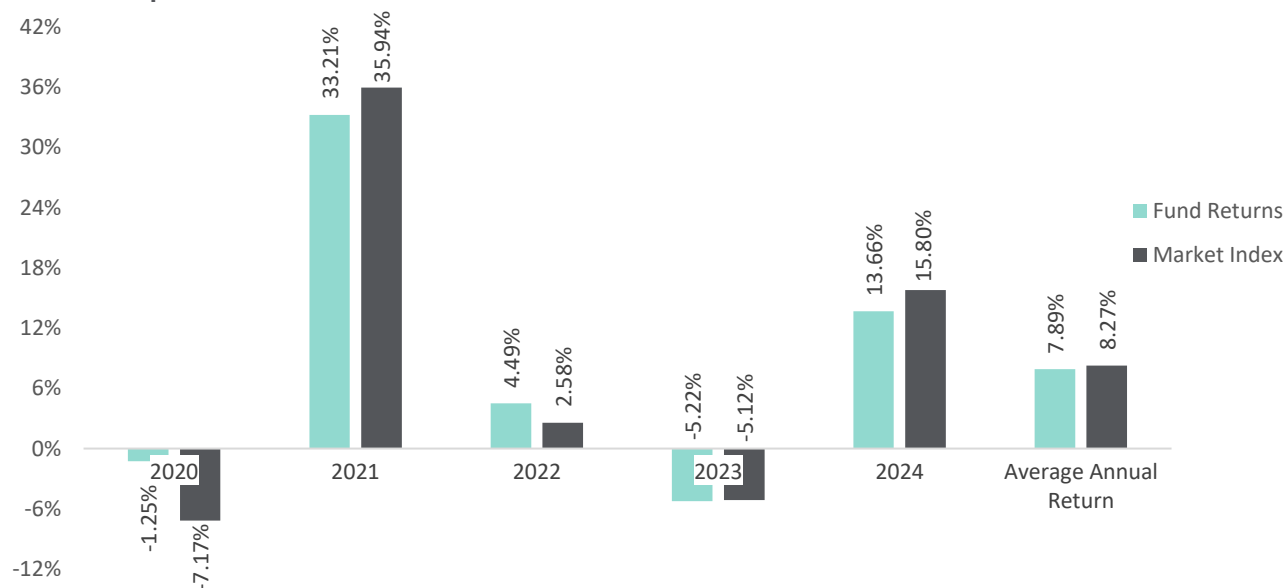
How has the fund performed?

The market index return for the fund is a composite index comprised of S&P/NZX Bank Bills 90 Day Index (5%); S&P/NZX Investment Grade Corporate Bond Total Return Index (15%); S&P/NZX 50 Gross Index (20%); S&P Global BMI (NZD Hedged) Net Total Return (60%), being the fund's relevant benchmark as stated in the Statement of Investment Policy and Objectives.

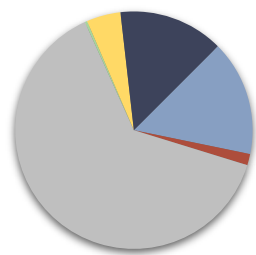
Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawal from or switching funds), although these are not currently charged. See the PDS for more information about those fees.

Example of how this applies to an investor

Annie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Annie received a return after fund charges were deducted of \$947 (that is 9.47% of her initial \$10,000). Annie did not pay any other charges. This gives Annie a total gain after tax of \$857 for the year.

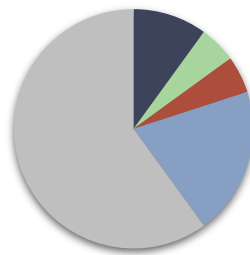
What does the fund invest in?

- International fixed interest: 0.32%
- Listed property: 4.64%
- New Zealand Fixed Interest: 14.31%

Currency hedging

The fund's exposure to assets denominated in foreign currencies was 70% of which 100% was hedged back to NZD.
