What is the purpose of this update?

This document tells you how the Mint New Zealand SRI Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mint Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Typically invests in New Zealand listed equities and has an investment objective of outperforming the S&P/NZX50 Gross Index by 2% per annum, before fees, over the medium to long-term. The Fund is designed to meet specific responsible investment criteria, with the aim of building a portfolio where the holdings in aggregate, generate a better ESG score in our systems than the benchmark S&P/NZX50 Gross Index.

What are the risks of investing?

To determine the risk indicator, actual returns from the S&P/NZX50 Gross Index were used as this Fund has not been in operation for the required 5 years (inception 12 October 2017). As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund.

How has the fund performed?

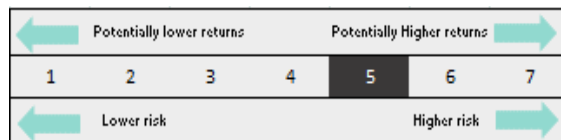
The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

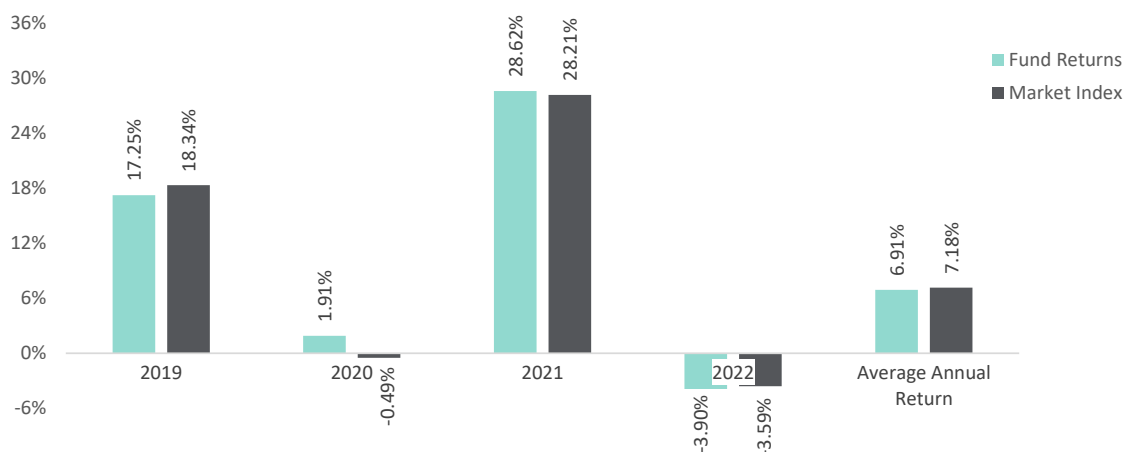

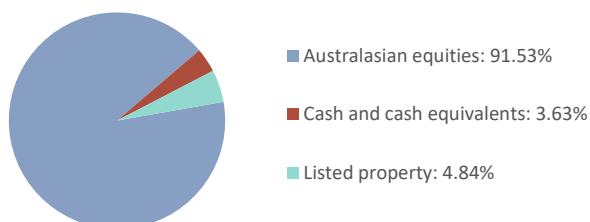
Example of how this applies to an investor

Annie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Annie incurred a loss after fund charges were deducted of -\$1548 (that is -15.48% of her initial \$10,000). Annie did not pay any other charges. This gives Annie a total loss after tax of -\$1599 for the year.
