

# Mint Asset Management Funds Mint New Zealand SRI Equity Fund

Fund Update for the quarter ended 30 June 2023

## What is the purpose of this update?

This document tells you how the Mint New Zealand SRI Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mint Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

Typically invests in New Zealand-listed equities and has an investment objective of outperforming the S&P/NZX50 Gross Index after fees and expenses over the medium to long term, as presented in the Product Disclosure Statement (effective 30 June 2023). The Fund is designed to meet specific responsible investment criteria, with the aim of building a portfolio where the holdings in aggregate, generate a better ESG score in our systems than the benchmark.

# What are the risks of investing?


The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


#### How has the fund performed?


#### Example of how this applies to an investor

Annie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Annie received a return after fund charges were deducted of \$1,177 (that is 11.77% of her initial \$10,000). Annie did not pay any other charges. This gives Annie a total gain after tax of \$1,101 for the year.


## What does the fund invest in?
